Please note Russell's new address & phone number. Russell had trouble with his original BMW engine overheating. He tried different props & pitch without satisfactory results. He tried a Mercury long shaft outboard, which didn't work to his satisfaction either. Russ then re-powered with a 8 hp Yanmar fitted with a Max Prop (3 blade) and is now satisfied with the results.

Russ has installed Pro Furl roller furling on both the Jib & Staysail. Even when it is very windy he can reef at any point of sail. While sailing, Russ had his prop pop off. Has anyone else had this problem? On Tattooed Lady, we put a wedge in the rudder post to eliminate this possibility. Can anyone else offer any suggestions.
