Sapo, FC # 10

"Sapo is in Malaysia. The route: Mexico, French Polynesia, Cooks, Tonga, Marshalls, Vanuatu, FSM, Guam, Philippines, Borneo, Singapore, Malaysia, Thailand, Malaysia -- 4 years +."

"I am finding all parts of planet Earth beautiful and worth the trouble to visit, although some places are better for boats. Speaking of which, *Sapo* has never failed to meet the challenges of the Pacific Ocean; Philippine, Sulu, South China Seas; Singapore, Malacca Straits; and Andaman Sea. With my life (not to mention comfort and happiness) dependent upon a vessel of which 'everything is essential and everything breaks' I am very glad that *Sapo* is built so well."

"Clearly an FC can circumnavigate. If you decide to follow in my wake I recommend simplification --'down'grade as opposed to upgrading. And back up everything; get two of everything possible. Skip refrigeration (no ice either), use a bucket instead of the head, and don't install or stow anything on deck -- at best it gets in the way, at worst it washes off. I still have jerry jugs & propane tanks on deck - but it surprises me!"

"I've been in the tropics 4 years or so - still sweat a lot, but dread the thought of being cold. Must drop below 30/35 degrees to get around S. Africa and I'm already dreading it even though its more than a year away (at best)."

An owner or two ago, it was named *Tatooed Lady*, which was one of the boats you had been unable to locate. I recently built a 7.5 foot, 60 pound, plywood sailing dinghy to lie on the foredeck, an arrangement that has worked well so far, except that I wish the dinghy was about four feet longer. My previous boat was a 16 foot plywood cat-yawl I built that drew only 22 inches and taught me a lot of bad habits; I can report that the FC takes the ground well. Fortunately the bottoms here are mostly sand or mud, but I'm hopeful that an old dog can learn new tricks. I have to keep saying to myself, 'three-and-a-half feet, three-and-a-half feet'."
